

**ORDINANCE NO. 07-2018**

**INTRODUCED BY: MAYOR JAMES GRAVEN**

**AN ORDINANCE AMENDING CHAPTER 881 OF THE CODIFIED ORDINANCES OF THE CITY OF OLMSTED FALLS REGARDING MUNICIPAL INCOME TAX FOR TAX YEARS BEGINNING ON OR AFTER JANUARY 1, 2016 AND DECLARING AN EMERGENCY.**

**WHEREAS**, On December 22, 2015, Olmsted Falls through Ordinance No. 53-2015 modified certain sections of Chapter 881 of the Codified Ordinances of the City of Olmsted Falls regarding municipal income tax for tax years beginning on or after January 1, 2016; and

**WHEREAS**, Section 881.07(C)(1)(d) and Section 881.18(C)(2)(b) require further modifications in accordance with the recommendation of the Finance Director, as reflected in Exhibit "A" attached. Now therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, OHIO, THAT:**

**SECTION 1.** Sections 881.07(C)(1)(d) and Section 881.18(C)(2)(b) shall be modified to reflect necessary updates to Chapter 881 of the Codified Ordinances of the City of Olmsted Falls regarding municipal income tax for tax years beginning on or after January 1, 2016, as provided in Exhibit "A" attached.

**SECTION 2.** The Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that all deliberations of this Council and any of its committees that resulted in such formal action, took place in meetings open to the public, in full compliance with all legal requirements, including without limitation, those set forth in Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls for the reason that the new city tax code must be in place effective January 1, 2016. Upon passage by the affirmative vote of no less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law, this Ordinance shall take effect and be retroactively applied from January 1, 2016 and thereafter.
