

ORDINANCE NO. 72-2019

INTRODUCED BY: MAYOR JAMES GRAVEN AND COUNCIL AS A WHOLE

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH POGGEMEYER DESIGN GROUP AND EXPEND FUNDS RECEIVED BY THE CUYAHOGA COUNTY COMMUNITY DEVELOPMENT SUPPLEMENTAL GRANT (CDSG) FOR FISCAL YEAR 2018/2019, IN AN AMOUNT NOT TO EXCEED \$50,000 AND DECLARING AN EMERGENCY

WHEREAS, in Resolution 68-2018 the Olmsted Falls City Council authorized the acceptance of the Cuyahoga County Community Development Supplemental Grant for Fiscal Year 2018/2019 in an amount not to exceed \$50,000.00; and

WHEREAS, a Request for Proposals was advertised in the newspaper on May 2, 2019 for a proposal for way proposal for wayfinding and branding and the city received two proposals, and it is deemed to be in the city's best interest to select Poggemeyer Design Group's proposal for this project in view of their expertise. Now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, STATE OF OHIO, THAT:

SECTION 1. Having considered the above recommendation, the Mayor is authorized to enter into a contract with Poggemeyer Design Group for the project in the downtown area to assist in the development of a study which will produce a Wayfinding Analysis Report, Community Brand Platform, Brand Identity Design, and Sign Program Design and Development.

SECTION 2. This study will lead to the creation of a branded, wayfinding system to support goals of navigation, economic development and safety with better signage and neighborhood recognition.

SECTION 3. This Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council, and that deliberations of this Council and its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls. It shall therefore take effect immediately upon passage by the affirmative vote of not less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
